Course Objectives/Learning Outcomes:

- Students will develop skills for the evaluation and use of legal materials. Such skills will allow students to address legal research questions from a diverse user base in any type of library.
- Students will learn how to conduct basic legal research using free and fee, print and electronic resources.
- Students will explore modern law librarianship: its institutions, best practices, and real-world examples.

Attendance:

This is an online course except for the one face-to-face meeting 10 September. The face-to-face meeting will take place in Macon, GA with a morning session at Macon State College. The afternoon session will be 2 p.m. to 5 p.m. at the Furman Smith Law Library of Mercer University School of Law.

CALI Lessons:

One tool the class will be using is lessons from the Center for Computer-Assisted Legal Instruction, or CALI. The lessons are on their website cali.org. You may use the authorization code 'FLORUVstu73' to create an account. As to take the lessons you will be quizzed on the content and a score assigned. Please send a screen shot or a copy of the grade report as proof of

completing the lesson. Do not worry the CALI score is not your grade, but I would recommend retaking the lesson if you score is less than 70%.

Assignments and Grades:

Legal Research: Assignments through out the semester will test your abilities to conduct research. Five assignments each 5% of final grade for total of 25%.

Reaction papers in response to various topics covered in the class. Each week I will offer up a vague suggestion of a topic regarding something recently covered in the class. You can pick three of them to write up in a 1,000 words and turn in by the following Monday. Each paper worth 5% of final grade for total of 15%.

Final Essay Paper and Research Assignment will be a combined 50% of final grade. Essay will be a 2,000 word response to a question posed to the class related to the roles of law libraries and is worth 25%. The Final Research Assignment will seek to tie together the earlier assignments having you go through an entire research process from beginning to end. Worth 25% of final grade.

Participation is worth 10%.
