- 4. RFP 20% of Course Grade [Objective(s): 2,3] Working in a group, prepare a RFP for library management system vendors.
- 5. Topic Discussions & Activities- 20% of Course Grade [Objective(s): 1, 2, 3, 4]

## STUDENT OPINION OF INSTRUCTION SURVEY
