#### **Course Description**

An introduction to concepts and processes in reference and information science and to fundamental information sources and services provided by libraries and information organizations. This overview of the reference function includes the history and future of reference service, question negotiation, information needs analysis, effective research strategies, evaluation of information sources in various formats, and ethics of information services.

Prerequisite: MLIS 7000 or consent of the instructor.

**SLO 9.** Produce a user aid for a targeted audience (PO 1).

## **Course Activities / Assignments / Requirements**

There are a number of assessments developed to meet ALA accreditation requirements on student learning outcomes. LiveText is the software that the MLIS Program selected for keeping track of these assessments, and all MLIS students are required to purchase access to the LiveText system. The LiveText subscription is not tied to when you entered the program or to when you plan to graduate. Once you purchase your subscription to LiveText, it is good for up to five years. You will also have personal access to other LiveText features you may find useful once you have your subscription. Please consider the purchase of your LiveText subscription as you would the purchase of any other textbook or piece of software required for a course.

MLIS 7100 includes two assignments that partially fulfill the ALA accreditation requirements on assessing MLIS Program Objectives. You will find both marked as "necessary to fulfill requirements for this course" on pages 4 and 5 of this syllabus. You must submit the final copies of the two assignments to your LiveText account.

The following list is a brief overview of the assessments used to measure learning outcomes included in this course. Complete instructions for each assignment along with grading criteria will be posted on the BlazeVIEW course site in advance of that assignment's due date.

## **Graded Discussions** (SLO1 SLO2, SLO8) – **10 Points**

You will participate in <u>Two</u> threaded discussions related to course readings on BlazeVIEW. The discussion board is available to you for one week. During that time, you are expected to make meaningful contribution and interact with your classmates.

## Search Strategy Assessment (SLO3, SLO5, SLO6) – 15 Points

Using the search techniques and strategies demonstrated in class, you will plan a series of searches and document your strategies in the worksheet provided. You will also answer some basic questions on information resources in general.

## Reference Consultation Project (SLO1, SLO2) – 30 Points

## Part I. - Reference Interview Evaluation – 10 Points

You will evaluate a simulated reference transaction video and the librarian's techniques in the video; discuss what went well and how certain parts of the transactions can be improved.

## Part II. – Reference Consultation Project -20 Points

You will conduct one simulated reference transaction with one of your classmates. The final product is a video similar to the one you evaluated in *Reference Interview Evaluation*. In the video, "the reference librarian" has to assist "the client" in locating resources that contain the answer to the client's questions. **Successful completion of this project is necessary to fulfill requirements for this course.** 

## Reference Transaction Assessment (SLO5, SLO6, SLO7) – 30 Points

You will answer two sets of assigned questions in written format using relevant resources and techniques and confirm the reliability of your sources. You will present the answers following the specified format.

# 2) <u>Research Reference Question Set – 20 points</u> Successful completion of this assignment is necessary to fulfill requirements for this course.

## Pathfinder (SLO4, SLO7, SLO9) – 15 Points

You will create a pathfinder on a specific topic aimed at a specific user group.

#### **Course Grade**

Students can earn a maximum of 100 points in this course. Course grades will be awarded as follows:

- D: 60 69 points
- F: fewer than 60 points.

## **Late Policy**
